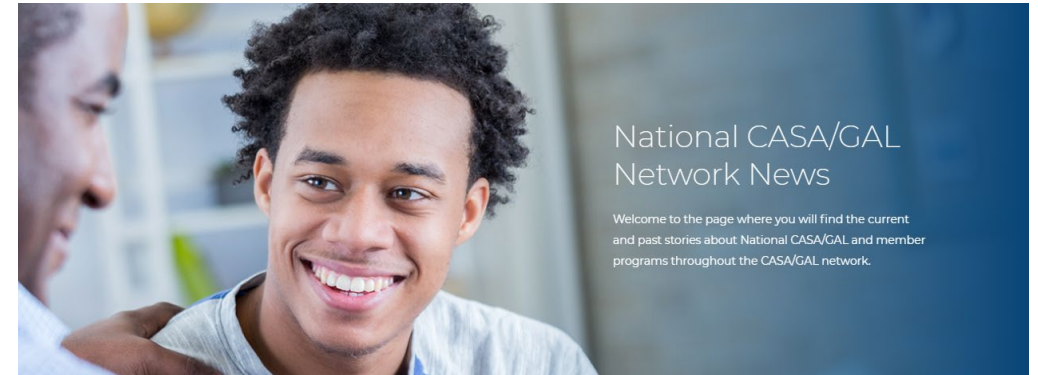

- Discussions are underway to transition the conference workshops to the 2020 webinar offerings catalog
- Planning is under way to offer the following one-day institutes: Volunteer Administration, Strategic Storytelling for Social Impact, Leading in a Time of Crisis, Strategic Management, Racial Equity, and Talent Management

Emergency Grants Update

- **Technology Grants Available | Funding available to help manage video conferencing costs for virtual training (e.g. Zoom) and to utilize Flex Learning as pre-service training option (Moodle support)**
 - Applications have been received from 113 members
 - No direct funding to programs; credit for Moodle Room fees and payments directly to Zoom
- **Emergency Grants. Funding for unanticipated financial hardship**
 - 62 inquiries received to date with 34 applications received

Both opportunities are still open for another week. Submissions have decreased and other non-National CASA/GAL resources have become available (e.g. state funding, PPP)

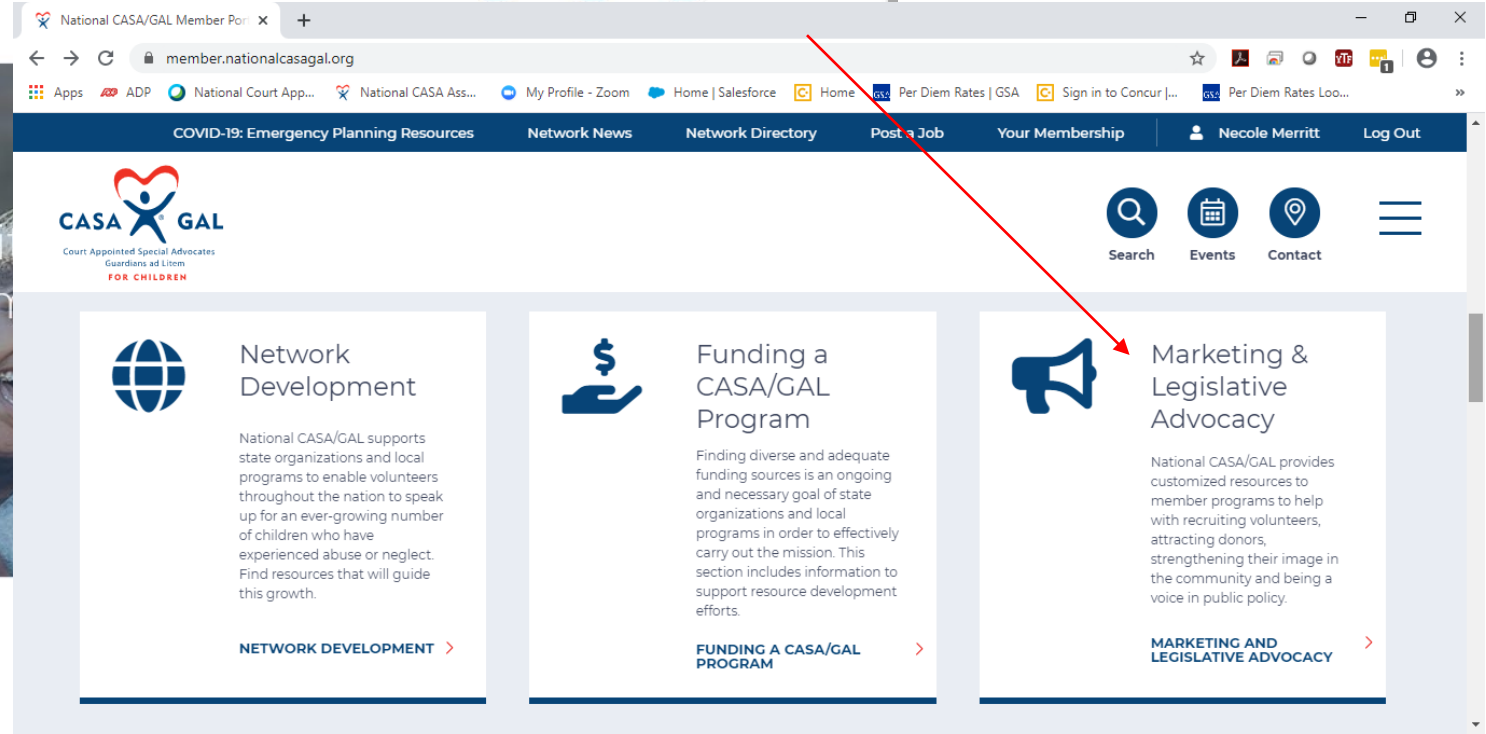
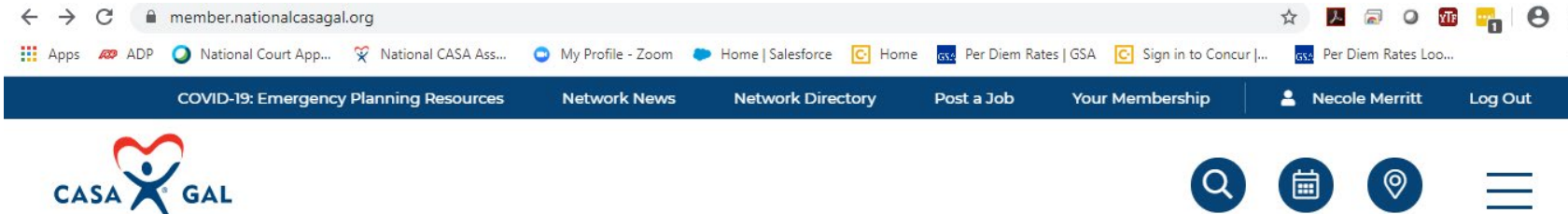

COVID-19 Stimulus Packages

- Coronavirus Preparedness and Response Supplemental Appropriations Act (“Phase 1”)
- Families First Coronavirus Response Act (“Phase 2”)
- Coronavirus Aid, Relief, and Economic Security Act (“CARES Act” or “Phase 3”)
- Paycheck Protection Program and Health Care Enhancement Act (“Phase 4”)
- Phase 5 and beyond?



Paycheck Protection Program & Healthcare Enhancement Act

- \$483.4 billion stimulus package - interim economic relief measure
- Specifically the bill includes:
 - \$310 billion for the Paycheck Protection Program (PPP), including \$60 billion for smaller lenders to make PPP loans
 - \$50 billion for the Economic Injury Disaster Loan (EIDL) program, and an additional \$10 billion in Emergency EIDL grants that disaster loan recipients can receive
 - \$75 billion for hospitals and other health care providers for treating COVID-19 patients and lost revenues under the DHHS Public Health Social Services Emergency Fund (this is in addition to the \$100 billion provided in the CARES Act for this purpose)
 - \$25 billion in additional funding for COVID-19 testing, including \$11 billion for states and local governments to expand testing

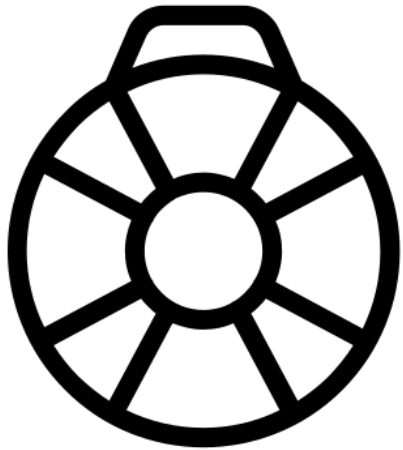

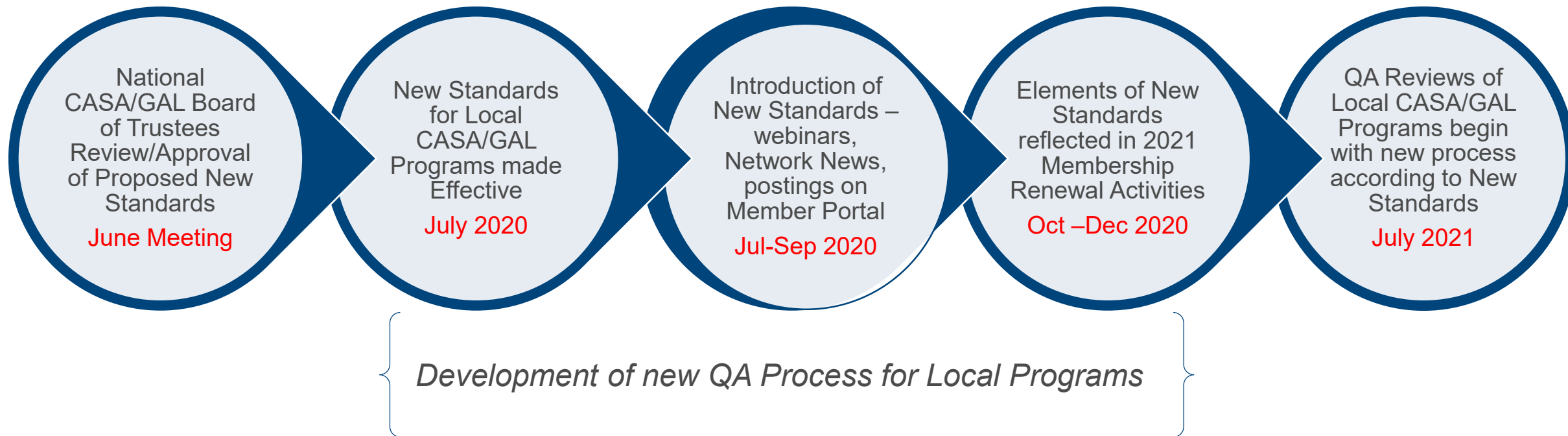

Who does this apply to?

Any representative or organization acting on behalf of a CASA/GAL member organization that is:

- contemplating being a party to an agreement,
- already a party to an agreement, or
- exploring the option of seeking grant or other funding to be a party to an agreement, or
- being approached or required to be involved

...to undertake any research study, including academic study projects, that relates to work or activities generally conducted by the CASA/GAL network

Who doesn't this apply to?

Auxiliary organizations should not engage in research studies for work or activities related to support of a CASA/GAL state organization or local program.

Auxiliary organizations exist to advance and support the work of another organization. Within the CASA/GAL Network, auxiliaries can be a key support component for state organizations and local programs that are unable to raise funds directly.

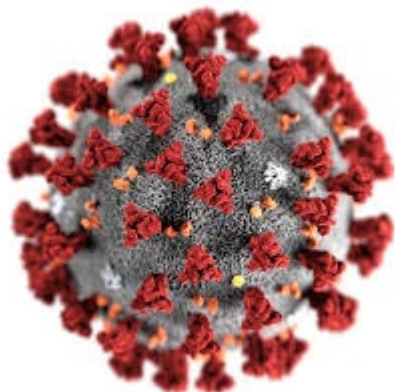
