### Definition of Best Interests





#### **Definition of Best Interests**

Although in most states, "best interests of the child" does not have a specific definition, it is generally used in laws and policies as a standard for making judicial decisions regarding the placement and care of a child.

A child's best interests guide the deliberation that courts undertake when deciding what type of services, actions, and orders will best serve the needs of a child as well as who is best suited to care for the child. "Best interests" determinations are generally made by considering many factors related to the child's circumstances and the parent or caregiver's circumstances and capacity to parent, with the child's ultimate safety and well-being as the paramount concern.
